NOTICE INVITING QUOTATION

As per direction of Labour Department, WB sealed quotations are invited from reputed Chartered accounts firm empanelled with CAG for Appointment as statutory auditor for internal audit of accounts of West Bengal Labour Welfare Board which is a statutory and autonomous body under Department of Labour, Government of West Bengal for the financial year 2023-24.

Terms and Conditions:

1. The audit will be done at the Head Office at P-3, C.I.T. Scheme VII-M, Kankurgachi, Kolkata – 700054 and Regional Office at Dagapur Complex, P.O. - Pradhan Nagar PIN-734403, District: Darjeeling.
2. The quoted audit fee shall be inclusive of all charges, taxes and duties and out of pocket expenses. However, GST will be payable extra as per norms.
3. **Only CAG empanelled Auditor will be eligible to apply. The empanelment number is required to be mentioned in the application.**
4. The Auditor firm should have at least 30 years of experience and executed similar assignment under Government body/ undertaking/ Autonomous body/ statutory body, copy of such orders to be enclosed (**mandatory**)
5. The Auditor firm must have office at Kolkata or adjacent area.
6. The Auditor firm must submit Self attested copy of Valid Trade License, PAN card, GST Registration Certificate, last year IT Return, Service Tax Registration Certificate.
7. The quotation must clearly indicate **“Quotation for appointment Statutory Auditor for audit of accounts of West Bengal Labour Welfare Board at the head office at Kolkata and regional office at Dagapur, Siliguri for the financial year 2023-24”**.
